

LUDLOW ORDINANCE NO. 2019-2

AN ORDINANCE AMENDING ORDINANCE 2004-10 TO PROVIDE THAT CHAPTER 95.10 "PIT BULL TERRIERS PROHIBITED" SHALL BE REPEALED

Whereas, the City of Ludlow, Kentucky is desirous to amend Ludlow City Code to repeal the section pertaining to the ban of a breed of dogs known as Pit Bull Terriers; and

Whereas, it is the intent of the City of Ludlow to repeal breed specific animal control for vicious dogs.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LUDLOW AS FOLLOWS:

SECTION I

That Chapter 95: Animals is hereby amended to repeal "Section 95.10: Pit Bull Terriers Prohibited" as follows:

	an American Staffordshire Terrier or a Staffordshire Bull Terrier; 2) Is registered with the United Kennel Club as an American Pit Bull Terrier;



Club for either the American Staffordshire Terrier or the Staffordshire Bull Terrier which were published with an example photographed in the 15 th edition of the Complete Dog Book in 1977, (a copy of this material is attached to the ordinance) on file with the city clerk; or
4) Has predominant physical characteristics which are those of either the American Staffordshire Terrier or the Staffordshire Bull Terrier indicated in the standards of the American Kennel Club which were published with an example photograph in the 15 th edition of the Complete Dog Book in 1977, (a copy is attached to this ordinance) and on file with the city clerk.
SECTION II
Any and all ordinances or parts of ordinances in conflict with this ordinance shall be and hereby are repealed to the extent of said conflict.
SECTION III
This ordinance shall take effect and be in full force from and after its passage, publication, which may be in summary form, and recording, according to law.
