The City of Ludlow will receive sealed bids from qualified contractors for the furnishing of all labor, materials and the performance of all work required for the construction on Adela Avenue of curb-line milling, asphalt resurface from Sandbank Road to Elm Street (KY 8), replace sidewalk/curbing and new sidewalk as needed from Sleepy Hollow Drive (KY 1072) to Elm Street (KY 8).

Prime and DBE Contractors submitting a bid must be pre-qualified by the Kentucky Transportation Cabinet prior to the public reading of the bid on October 14, 2021 at 10:00 AM Eastern Standard Time at Ludlow Municipal Center.
